engagement session + book \$500

Tell the world that you're engaged with a special photosession. This 1.5 hour session includes 1 location and 20 distinct photos, including beautiful macro shots of your engagement ring. They look great on save-the-dates, on display at your reception, or printed in a guest book.

extra hour \$200

It's your special day, why not make it last longer?

extra book \$200

Makes a great gift for parents!

extra dvds/cases \$50

Keep one in a safe deposit box =>

all images \$250

everything my second shooter and I shoot, unedited, on a disc. Usually 2000+ images.

A few words on some package items:

10 years of cloud storage

If, for whatever reason, you lose the digital images I give you, I will have backups. I'll keep your photos safely nestled in the cloud for the next 10 years. There is a \$100 access fee to get them out of the cloud (these particular clouds are very high up).

printed proofs

A few weeks after your wedding, you'll receive a wooden box at your door that contains 150 4x6 prints from your wedding. This is a really special way to first view your photos, and one 4x6 makes a great addition to that thank you note to the aunt who gave you the KitchenAid Stand Mixer!

wedding album

25 pages (50 sides), custom-designed, beautiful paper, hard cover. You'll love it. We can do additional pages--let's talk.

two photographers

Your wedding only happens once, and so not only do I always have a backup camera, backup lenses, backup batteries, but I also have a backup of myself! The second shooter expands what you'll get pictures of as well as guaranteeing that you'll have a professional photographer, no matter what happens.

Drew Hoover Photography Wedding Contract

It is understood this Studio/Photographer is the exclusive official photographer retained to perform the photographic services requested on this Contract.

Upon signature and receipt of the retainer (equal to half the total amount), the Studio/Photographer shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, unless the Studio is able to fully replace the cancelled reservation, all retainers are non-refundable, even if the date of the wedding is changed or the wedding is cancelled for any reason.

No part of any order, including previews, will be delivered until the balance is paid in full.

The Studio/Photographer may substitute another photographer to take the photographs in the event of Studio/Photographer's illness or of scheduling conflicts. In the event of such a substitution, Studio/Photographer warrants that the photographer taking the photographs or video shall be a competent professional.

If the Studio/Photographer cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer's illness or emergency, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera or other media malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Studio/Photographer fails to perform for any other reason, the Studio/Photographer shall not be liable for any amount in excess of all monies paid.

The charges in this Contract are based on the Studio/Photographer's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.

NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs or videos elsewhere without Studio's/Photographer's permission, and violators of this Federal Law will be subject to its civil and criminal penalties. Posting to personal social media accounts is permitted.

This Contract incorporates the entire understanding of the parties and is governed by the laws of Montgomery, AL. Any modifications of this Contract must be in writing and signed by both parties.
